

PROCEDURES FOR ENTRY TO ST MAARTEN, SABA & ST KITTS

St Maarten: Since November 1, 2022, St Maarten doesn't require any vaccination status or test to visit the island. It is no longer required to complete the Electronic Health Authorization system (EHAS) Application.

Saba doesn't require any vaccination status or test to visit the island.

St Kitts: Since August 15, 2022, The Federation of St. Kitts and Nevis doesn't require any vaccination status or test to visit the island. However, all incoming passengers must complete and submit the Immigration and Customs ED form which includes a Custom and Border Form at knatravelform.kn. **All KN applications for St Kitts require upload of the passport copy, a photo and an \$8.50 fee.**

As of June 1st, 2023, Explorer Ventures has made the decision to discontinue our requirement for all guests coming aboard the *Caribbean Explorer II* to present negative COVID-19 test results prior to boarding the vessel, regardless of vaccination status. For the safety of all guests and crew, we still encourage you to test prior to leaving home. If any guest becomes symptomatic during a charter, testing, isolation and/or disembarkation may be necessary at your own expense.

Note regarding St. Kitts immigrations/customs requirements: St. Kitts **requires** all travelers to complete the [KNA Travel Form](#) prior to arrival. We recommend completing this form the day before you depart for St. Maarten. Please bring the KN form authorization email with you and present to the Captain and the Purser. They will need the information in the email for St. Kitts immigration.

Note regarding St. Maarten immigrations/customs requirements: St Maarten now **requires** all travelers to complete an immigration form to be completed online, prior to your arrival. [Click here to get access to the official website.](#)



INSURANCE & EHAS HEALTH APPLICATION FORM

All visitors are required to provide the following prior to travel:

- Insurance which covers COVID-19 medical costs and full hospitalization, doctor's visits, prescription and air ambulance **is not required anymore since October 15, 2022.**
- In St Kitts, a completed [ENTRY FORM](#) within 72 hours prior to arrival must be completed. Upon arrival, all visitors must fill in a health questionnaire.

MANDATORY MASK USE

Face mask use is not mandatory anymore.



OPTIONAL LAND TOURS

You can visit any place in St Maarten. Saba & St Kitts optional visits are offered again since October, 2022.
